Directives for Student Dormitory Electricity Consumption

Adopted by the General Affairs Council, Spring semester, 2016 academic year, on May 3, 2017

1. The NTNU Directives for Student Dormitory Electricity Consumption is formulated in accordance with Article 7, Subparagraph 4 of the NTNU Regulations for Student Dormitory Counseling.
2. The NTNU Directives for Student Dormitory Electricity Consumption is formulated for the purpose of clearly assigning the responsibilities of boarders in electricity consumption, maintain dormitory electrical equipment, and ensure the safety of electricity consumption.
3. The roommates are responsible for maintaining the electrical equipment shared in the dormitory room jointly. Each student is individually responsible for the electrical equipment installed to the assigned bed. The bed occupant shall log in to the repair system voluntarily to contact maintenance personnel for repair service or for equipment replacement when necessary.
4. Power supplies and electrical equipment in public areas (including basements) may not be changed discretionally.
5. It is strictly prohibited to bring or use personally owned electric pot, freezers, rice (electric) cooker, electric cooking stove, electric kettles, electric hot water bottle, electric irons, ovens, electric stove, microwave ovens, electric heaters, etc., and other items that consume more than 500 watts (except for hair dryers) of electricity in the dormitory; also, they are not allowed to be connected to the power supply without authorization in order to avoid danger. Students who bring in the aforementioned electrical appliances that consume high electricity will be deprioritized (equivalent to a deduction of 10 points) in applying for a dormitory room; also, a violator will be ordered to leave the dormitory.

An application must be filed to the Student Housing for approval in advance with all necessary materials submitted for the use of a refrigerator or dehumidifier in the dormitory.

6. Multiple sockets and extension cords with the label of Bureau of commodity standards, M.O.E.A. should be used in the dormitory when necessary. Do not place or use noncomplying electrical appliances as listed in Article 5. Violators will be disciplined in accordance with the provisions of Article 7.

7. Boarders shall conduct self-inspection every semester to maintain the safety of electricity consumption in the dormitory, and shall fill in the report in accordance with the guidelines announced by the Student Housing. Boarders who fail to complete the inspection report within the time limit will be penalized with 5 points deducted and will be inspected by the inspection team.

8. The NTNU Directives for Student Dormitory Electricity Consumption is approved by the Office of Student Affairs Council meeting and will be implemented after being approved by the University President, same for the amendments.
